**General Requirements**

- Must carry copy of permit and General Provision dated 1-19 and comply with them.
- Regulations for your Emmet County OS/OW moving permit are the same as your state permit. See “General Provisions” and carry them with your permit. Also, see attached map for more information. Map must be carried with your permit.
- Road must be clear of ice & snow & visibility must be at least ¼ mile.
- When unpaved (gravel) road conditions are soft following spring snowmelt or after rainfall events exceeding 2”, or if road conditions would be damaged by OW loads, please obtain permission from the Emmet County Engineer’s office before travel is attempted.
- Hazardous materials must be transported in compliance with applicable federal regulations.
- Necessary city and/or county permits must be obtained separately.
