Chairman Pluth called the meeting to order. The Board and those present recited the Pledge of Allegiance. Motion by Quastad, second by Glasnapp to approve the minutes from last week's meeting also approving them for publication. All ayes, motion carried.

During public forum, Hash and Schumacher reported on meetings attended. The Board discussed the benefits and detriments of meeting virtually.

Emmet County Treasurer informed the Board that she will be advertising for a position in the Treasurer's Office due to a resignation.

Allison Fisher, Emmet County Engineer's Office presented the Fuel and LP bids as follows:

Motion by Quastad, second by Glasnapp to approve the low fuel bid from Pro Cooperative for \$6,300. All ayes, motion carried.

Emmet County Auditor & Commissioner of Elections, Amy M. Sathoff reported on how the drive thru voting went on Primary Election Day and requested that the Board raise the wages to include an additional \$2.00 per hour for the Precinct Workers for this Election only due to the extreme conditions. Motion by Glasnapp, second by Hash to grant the request. All ayes, motion carried.

Emmet County Auditor, Amy M. Sathoff presented the Departmental Head update on the re-opening of the Courthouse. Updates include:

- Clerk of Court now has plexiglass installed.
- Phase 1 will go thru the end of June.
- There are concerns on the effectiveness of the Thermascan unit.
- Department Heads will continue to meet weekly and Departments are working together to serve the public.

The Board discussed dues to the IA Drainage District Association. Motion by Quastad, second by Glasnapp to pay the full amount of \$7,437.50. All ayes, motion carried.

The Board canvassed the results of the June 2, 2020 Primary Election as presented by Colleen Anderson, Auditor's Assistant. Motion by Hash, second by Glasnapp to approve the results as listed in the canvass books. The canvass books are on record in the Auditor's office for review. All ayes, motion carried.

Emmet County Assessor, Barb Bohm shared with the Board that there are 2 vacant positions on the Board of Adjustment and 1 on the Zoning Commission due to a new law that requires members of both Boards to live in rural Emmet County. She also shared that Rich McKean is up for reappointment.

The Board discussed potential appointments and this will be put on next week's agenda.

Motion by Schumacher, second by Glasnapp to reappoint Rich McKean to the Zoning Commission. All ayes, motion carried.

Emmet County Public Health Nurse, Kathy Preston gave a situational update on COVID19. Currently there are 35 cases in Emmet County. She also shared numbers from neighboring counties. As of last Friday, the State has taken over contact tracing for Emmet County, due to staffing issues and the rise of Emmet County cases. Preston shared that there is now a lot more activity in this area.

Preston also shared that they are exploring testing options for first responders and healthcare workers.

EMA Director, Travis Sheridan asked the Board to match an EMPG for a \$35,000 mobile command/immunization trailer. The old trailer will become a HAZMAT trailer. EMPG match would be possibly \$7,000 or more. Motion by Schumacher, second by Hash to commit the EMPG match dollars for the trailer. All ayes, motion carried.

Sheridan also spoke with the Board on potentially making the Serge Site a permanent Shelter by making the current electrical permanent and utilizing a generator EMA already has. The work would cost approximately \$11,100. There is a potential for funding thru preparedness funds with the Hospital for approximately a third of the project. The Board asked for exact numbers and a tour next Tuesday at 8:30 am of the building, as they had many questions regarding the project.

Motion by Quastad, second by Schumacher, to approve the County's claims as listed in the claims register. All ayes, motion carried.

Motion by Quastad, second by Glasnapp to approve the County's drainage claims. All ayes, motion carried.
