Davis-Oeth is applying for a N40 resurfacing \$1.1 million project. If approved Emmet County would receive 60% regional funding for the project.

At 9:30 a.m., Chair Quastad opened the public hearing for the FYE2022 Emmet County Maximum Property Tax Levy. Present were Auditor, Amy M. Sathoff, Emmet County Board members, Pluth, Quastad, Schumacher, Hansen and Glasnapp. Members of the media Mike Tideman and Ed Funston were present. There were no written comments received. Auditor Sathoff presented Resolution 21-08 and explained the reason for this public hearing was due to 2019 legislation. This sets the max levy that Emmet County can levy for FYE 2022. The actual levy amounts will be set at the next public hearing. Motion by Pluth, second by Glasnapp to close the public hearing at 9:46 am. All ayes, motion carried.

Approval of FYE 2022 Maximum Property Tax Dollars

WHEREAS, the Emmet County Board of Supervisors have considered the proposed FYE 2022 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county website, and

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 2, 2021.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Emmet County that the maximum property tax dollars for General County Services and Rural County Services for FYE 2022 shall not exceed the following:

General County Services - <u>\$3,743,458</u> Rural County Services - <u>\$1,354,335</u>

The Maximum Property Tax dollars requested in either General County Services or Rural County Services for FYE 2022 does represent an increase greater than 102% from the Maximum Property Tax dollars requested for FYE 2021.
