**APPROVAL OF WAIVER OF EMMET COUNTY'S RIGHT TO APPEAL ISSUANCE
OF FINAL CONSTRUCTION PERMIT FOR THE CONSTRUCTION OF CONFINED ANIMAL FEEDING
OPERATION BY THE IOWA DEPARTMENT OF NATURAL RESOURCES.**

BE IT RESOLVED by the Emmet County Board of Supervisors as follows:

Section 1 The Emmet County Board of Supervisors has received notice from the Iowa

Department of Natural Resources (DNR) that Summit Pork has been issued a draft permit for the construction of a confined animal feeding operation building(s) at SE SW 30 T98N R31W of Denmark Township in unincorporated Emmet County

Section 2 The Emmet County Board of Supervisors reviewed the construction permit application and the manure management plan and determined that both appeared to be in compliance with the requirements of the Master Matrix, Iowa Code Section 459 and Iowa DNR rules and recommended approval of said application on June 1, 2021.

Section 3 The Emmet County Board of Supervisors hereby waives its right to appeal the issuance of the final permit within the fourteen (14) day limit from the time of receipt of notice of the issuance of the draft permit.

Section 4 The Emmet County Board of Supervisors encourages the Iowa DNR to issue the Final Permit immediately upon notification of this waiver.

Section 5 The Emmet County Board of Supervisors authorizes the Board Chairman to (County Name) notify the Iowa DNR of this waiver.

Section 6 This resolution shall take effect immediately.

Resolution 21-22
Levy of Drainage District

WHEREAS, the Board of Supervisors of Clay, Dickinson, Emmet, and Palo Alto Counties do determine that an assessment should be levied on all the tracts of land, lots, railroad companies and public highways within the boundaries of Drainage District 61 Branch 61 in Clay, Dickinson, Emmet, and Palo Alto counties to procure funds with which to pay the cost of the above drainage district reclassification; and

WHEREAS, the Boards determined and find that the original assessment furnishes a fair and equitable basis for a proper apportionment of the costs and expenses of said assessment and the Boards concur that no good reason exists for a new or different assessment.

THEREFORE, BE IT RESOLVED by the Board of Supervisors of Clay, Dickinson, Emmet, and Palo Alto Counties that the following percentage of original assessment be levied on each tract of land, lots, public roads and railroad companies in those districts and that the County Auditor of Clay, Dickinson, Emmet, and Palo Alto Counties be directed and ordered to extend assessment of the following percentage of the original assessment and certify the same to the County Treasurer of each county, to be collected by the Treasurer in the manner as provided by law.

Supervisor Pluth was approached by Kenny Billings regarding support for a meal for Emmet County First Responders.

The Supervisors discussed the Emmet County Employee Christmas in July Party.

Emmet County Sheriff, Mike Martens and Emmet County Attorney, Melanie Summers Bauler joined the meeting to discuss the opening of the law center doors.

The Board discussed accessibility issues and evacuation issues for the Courthouse. Sheriff Martens has a phase in plan to open the doors.

Sheriff Martens reported that he has received a grant for bullet proof glass for the Sheriff's office.

Consensus of the Board was that Sheriff Martens should expedite his reopening process.

Zoning Administrator, Barb Bohm joined the meeting to discuss Suburban Residential Ordinance Violations. Bohm shared that there is a way to enforce the fact that a salvage yard is not a permitted use in a Suburban Residential District. Bohm would need the Supervisors to support enforcement of such a violations.

Enforcement of violations and cleanup costs could be assessed on property taxes. Enforcement would be complaint driven.

Summers Bauler mentioned that the properties could pose a public health risk. Consensus of the Board was to support sending the letter to the property owner of parcels 07-14-326-002 and 07-14-326-001 in Maple Hill. Also sending a letter to the owner of parcel 05-02-381-004 north of Estherville regarding the Suburban Residential Ordinance Violations.

Motion by Pluth, second by Hansen to issue the violation letters by adding public health concerns to the letter. Ayes: Pluth, Glasnapp and Hansen, Quastad abstained from the vote. Motion carried.

The Board reviewed the Construction Permit for the K& T Olson Swine 3 Site from the Iowa Department of Natural Resources.
