Quastad, Chair, called the meeting to order. All in attendance recited the Pledge of Allegiance. Motion by Pluth, second by Hansen to approve the minutes from September 28, 2021 and the Joint meeting on October 5, 2021, also approving them for publication. All ayes, motion carried.

During public forum, Emmet County Auditor, Amy M. Sathoff reported that Early Voting will begin tomorrow for the November 2, 2021 Combined City/School Election. Voters may cast their vote Monday thru Friday from 8:00 am to 4:30 pm in the Auditor's Office.

Quastad reported that there is a HAZMAT meeting tomorrow in Mason City.

Glasnapp reported on yesterday's Safety Meeting.

Mike Jensen and Richard McKean joined the meeting to discuss the Department of Natural Resources (DNR) plans for Swan Lake. Supervisor Quastad shared that the DNR will be getting Emmet County a letter stating that the DNR will be performing a survey of the drainage ditch before and after the project and that the DNR will fix the ditch if the project affects the Drainage Ditch.

Jensen shared that the landowners are fine with how the lake is currently and shared pictures of the lake.

No Public Meeting has been set at this time and no letter from the DNR has been received to date.

Jensen believes that the DNR owes Emmet County an Environmental Impact Study on the project and does not feel the DNR should proceed with the project.

Emmet County Engineer, Walter Davis-Oeth joined the meeting and reported that he had a productive meeting with the Union Pacific (UP) railroad and is waiting to see what comes from the meeting. The UP did say that they planned to repair the Christensen Crossing yet this year.

The reason inactive crossings can't be covered is that they would have to be abandoned first. The UP is not willing to abandon inactive rails or crossings at this time.

Supervisor Schumacher called Kossuth Supervisor Stecker to listen to the Bid Letting on the Tri84 project. Palo Alto and Kossuth County Supervisors were on the call along with Bolton & Menk. It is Bolton & Menk's recommendation to accept the low bid from Reutzel Excavating in the amount of \$124,379.00. Motion by Supervisor Stecker (Kossuth), second by Supervisor Solberg (Palo Alto) to accept the low bid of \$124,379.00 from Reutzel Excavating. All ayes from Kossuth and Palo Alto. Emmet will acknowledge at next week's meeting.

The Board discussed the ED 3 Annexation and Reclassification.

At 11:02 a.m. the Dickinson County Board of Supervisors joined the meeting telephonically via Zoom along with Rick Hopper of Jacobson Westergard and Chairman Quastad opened the Public Hearing on the Amended Annexation of Lands for Joint Drainage District ED#3. Emmet County Auditor, Amy M. Sathoff and a member of the media were present in Emmet County.

Dickinson County Board Members in attendance were William Leupold, Steve Clark, Tim Fairchild, Kim Wermersen and Jeffrey Thee. Jordan Moyer from the Dickinson County Auditor's Office along with the Dickinson County Attorney was also on the call. The Dickinson County Engineer, Dickinson County Assistant Engineer and two members of the media were also on the Zoom.

Drainage Attorney, James Hudson also joined the meeting via Zoom.

Rick Hopper of Jacobson Westergard addressed the Boards regarding their differences in opinion on the original annexation and the amended annexation reports.

Dickinson County agrees with the original Annexation and Emmet County disagrees with the original Annexation.

Drainage Attorney, James Hudson said that if no water leaves the lake than it should not be annexed but if it water does leave the lake than it should be included with the annexation.

Supervisor Pluth asked if a precedent would be set and James Hudson said there is no precedent in drainage.

Hopper's Professional opinion is that the lake should be included in the annexation and believes that there is a material benefit to the District.

The Boards discussed their differences on the annexation issue.

No written comments or complaints were received by the Dickinson or Emmet County Auditor's offices.

Motion by Pluth (Emmet), second by Fairchild (Dickinson) to close the public hearing. Ayes: All. Nays: None. Motion carried.

Motion by Pluth (Emmet), second by Glasnapp (Emmet) to exclude DD115 and the Lake from the ED#3 Annexation. Roll Call Vote: Ayes: Schumacher, Hansen, Quastad, Glasnapp and Pluth (Emmet) and Leupold, Clark (Dickinson). Nays: Fairchild, Wermersen and Thee (Dickinson). Motion carried.

At 12:01 p.m. the Joint Boards opened the Public Hearing on the Reclassification of Joint Drainage District ED#3.

No written comments or complaints were received by the Dickinson or Emmet County Auditor's offices.

Motion by Schumacher (Emmet), second by Hansen (Emmet) to close the public hearing. Roll Call Vote: Ayes: All. Nays: None. Motion carried.
