Quastad, Chair, called the meeting to order. All in attendance recited the Pledge of Allegiance. Motion by Schumacher, second by Hansen to approve the minutes from the last meeting, also approving them for publication. All ayes, motion carried.

During public forum, Public Health has an opportunity to have new fiber run to their building free of charge with the current construction throughout Estherville. This fiber could be utilized in the future if necessary. It was the consensus of the Board to have Public Health move forward on the fiber to the building.

The Board discussed various meetings they attended last week.

The Board and Auditor Sathoff shared preliminary plans for courthouse renovations on the west side of the building for a conference room/polling location room and an office for Emergency Management.

Emmet County Engineer, Walter Davis-Oeth joined the meeting and asked the Board for approval of a \$5,420 tailgate sander. The Board asked Davis-Oeth to obtain a second quote on the sander.

Davis-Oeth reported that during the rainy days recently crews were doing maintenance inside. Prior to the rainy days, crews were edge running and ditch cleaning.

Davis-Oeth is advertising for a seasonal snow plow operator.

Ike Petersen and Bud Schnell joined the meeting to discuss the ditch cleanout on 390th Avenue. Petersen and Schnell have safety concerns and believes that the road is worse now than it was prior to the cleanout. They also voiced concern regarding the amount of erosion going into the drainage ditch.

Some members of the Board and Davis-Oeth have visited the area.

Davis-Oeth explained the process and reported that crews followed protocols when doing the cleanout. Davis-Oeth reported that 26' is standard for gravel roads.

The Board and Davis-Oeth will meet with Petersen to inspect the area.

The Board discussed appointment of their Compensation Board Representatives. This will be put on the November 9, 2021 Agenda.

Emmet County Recorder Diann Minion joined the meeting and presented Resolution 21-28 approving the Amendment to Electronic Services System 28E Agreement with Iowa Land Records as follows:
