## LOCAL MATCH RESOLUTION 22-08

WHEREAS, Emmet County, (hereinafter called "the Subrecipient"), County of Emmet, has made application through the Iowa Department of Homeland Security and Emergency Management (HSEMD) to the Federal Emergency Management Agency (FEMA) for funding from the Hazard Mitigation Assistance Program, in the amount of \$33,950 for the total project cost and WHEREAS, the Subrecipient recognizes the fact that this grant is based on cost share basis with the federal share not exceeding 75%, the state share not exceeding 10%, and the local share being a minimum of 15% of the total project cost. The minimum 15% local share can be either cash or in-kind match, and

THEREFORE, the Subrecipient agrees to provide and make available up to \$5092.50 (Five thousand, ninety-two dollars and 50 cents) of local monies to be used to meet the minimum local match requirement for this mitigation grant application.

This resolution was passed and approved this 5th day of April, 2022.
