Quastad, Chair, called the meeting to order. All in attendance recited the Pledge of Allegiance. Motion by Hansen, second by Schumacher to approve the minutes from last week’s meeting, also approving them for publication. All ayes, motion carried.

During public forum, Supervisor Pluth shared that he will be attending a CO2 Pipeline Educational Training next week.

Supervisor Schumacher reported that Shane Walter will be retiring from the Sioux Rivers Mental Health Region. Schumacher shared that he had a RIDES meeting and NW IA Planning & Development meeting.

Emmet County Engineer, Walter Davis-Oeth joined the meeting and presented a utility permit from Estherville Communications for the installation of buried fiber optic cable along North 7th Street in Estherville. Motion by Pluth, second by Hansen to approve the permit. All ayes, motion carried.

Davis-Oeth reported that the Road crews are toward the end of the graveling.

The Board discussed a proposed pipeline ordinance that they been working on for Emmet County. Emmet County Attorney, Melanie Summers Bauler joined the meeting. Discussion was held regarding potentially adding the requirement of a Bond much like Dickinson County did. Concerns were expressed regarding liability and budgeting concerns.

Emmet County Auditor would like to get quote on having NW IA Planning & Development to update the County’s Ordinances (which is required every 5 years).

Summers Bauler does not believe that a hay ordinance is necessary. IA Code 317.11 covers the matter.

Emmet County Recorder, Diann Minion joined the meeting to discuss the current ATV Ordinance and changes made with recent legislation.

Motion by Schumacher, second by Glasnapp to set a Public Hearing for Emmet County FY2023 Budget Amendment #1 for July 26, 2022 at 9:30 a.m. All ayes, motion carried.
