Emmet County Attorney, Melanie Summers Bauler brought to the board a letter dated June 14, 2023 from ICAP addressing the recently amended Navigator Heartland Greenway LLC pipeline lawsuit and the coverages from ICAP (Iowa Communities Assurance Pool). This letter states that Navigator is now seeking "1. Inverse Condemnation and 2. Tortious Interference with Contractual Relationships and Prospective Business Advantage (an intentional tort)." Any award of damages would not be covered under the ICAP policy. Summer Bauler wanted to make the Board aware of the ICAP letter.

Peggy Mason joined the meeting to discuss the 99 County Bible Reading Marathon that occurs on the courthouse lawn. On July 14, 2023 all 99 counties in Iowa will be given different parts of the Bible to be read so that the Bible in its entirety is being read the same day. Mason wanted to make the Board aware that she and several others would be present on the courthouse lawn all through the summer participating in this marathon. The public is invited to join her.

Lincoln Township clerk and trustee replacement discussion. Quastad stated he discussed with the other trustees that they would need to appoint a replacement. Quastad has a name of someone to contact.
