Motion by Pluth, second by Quastad to approve the drainage claims as presented. All ayes, motion carried.

Emmet County Sheriff Mike Martens joined the meeting to discuss an offer that he has made to the Armstrong City Council to purchase the Armstrong Police 2014 Dodge Charger. Martens has offered \$17,250 for the vehicle. Martens will present a paid prior claim for this Friday to the Auditor's office.

Emmet County Assessor, Barb Bohm joined the meeting to update the Board on the new Stateline Objection to their valuation with the PAAB.

At 10:05 a.m. Chairman Glasnapp opened the Public Hearing regarding the Courthouse Building Addition. The Auditor's Office received no public comments.

One bid was received from Christensen Construction in the amount of \$1,979,400 for the project.

Motion by Hansen, second by Pluth to close the Public Hearing. Roll Call Vote: Ayes: Schumacher, Hansen, Pluth, Quastad and Glasnapp. Nays: None.

The Board discussed the bid received for the building addition. The Project was estimated to be \$1,407,600 and the only bid received from Christensen Construction came in at \$1,979,400.

Motion by Schumacher, second by Quastad to reject the bid and go back to the drawing board and redesign different elements to get the cost of the project down to a more affordable project. All ayes, motion carried.

Emmet County Recorder Diann Minion joined the meeting and requested a closed session pursuant to Iowa Code 21.5(1)(i).

Motion by Schumacher, second by Pluth to go into closed session per Iowa Code 21.5 (1)(i). Roll Call Vote: Ayes: Schumacher, Hansen, Pluth, Quastad and Glasnapp. Nays: None.

Motion by Schumacher, second by Hansen to come out of closed session. Roll Call Vote: Ayes: Schumacher, Hansen, Pluth, Quastad and Glasnapp. Nays: None.

No official business was decided in the closed session.

John Torbert of the Iowa Drainage District Association joined the meeting for his annual visit. Torbert discussed drainage legislation from the last legislative session.

IDDA has provided counties with a sample resolution to protect drainage districts from pipeline infrastructure.

Emmet County Engineer, Walter Davis-Oeth joined the meeting.

Davis-Oeth presented Resolution 23-18 for the establishment of a stop sign at the intersection of 190th Street and 380th Avenue as follows: Emmet County Resolution 23-18 Establishment of Stop Sign

WHEREAS, Public and Iowa DOT has expressed concerns at the intersection of 190th St. and 380th Ave over traffic volume and obstructed views, at partially controlled intersection and

WHEREAS, Review by County Engineer finds due to current construction projects in the area traffic has significantly increased to a point to create an intersection that may lead to accidents if left as currently controlled, and

WHEREAS, the Board of Supervisors is empowered under authority of the Iowa Code Section 321.255, to "place and maintain such traffic control devices upon highways under their jurisdiction as they may deem necessary... to regulate, warn, or guide traffic."

NOW THEREFORE, BE IT RESOLVED, The Board of Supervisors of Emmet County establish the stop regulation and appropriate signs be installed at the locations described as follows:

The Westbound approach to the intersection of 190th St and 380th Ave.

Motion by Pluth, second by Schumacher to adopt Resolution 23-18. Roll Call Vote: Ayes: Schumacher, Hansen, Pluth, Quastad and Glasnapp. Nays: None.

Motion by Schumacher, second by Hansen to approve Utility Permit from Iowa Lakes Regional Water to install pipeline to provide service to Nick Steinle's property at 1823 380th avenue in Estherville. All ayes, motion carried.

Motion by Hansen, second by Schumacher to approve a utility permit from Iowa Lakes Electric Cooperative for installing a three-phase 12,470 volt overhead line along the north ROW line of 210th street, beginning on the west side of 48th avenue and continuing west along the ROW for approximately 900'. The purpose of the construction is to move our existing facilities from the south ROW to the north ROW to avoid tress and eliminate an angle crossing. All ayes, motion carried.

The Board discussed various construction projects in Emmet County.

Motion by Hansen, second by Quastad to set a Public Hearing for August 1, 2023 at 9:30 a.m. for the FY2024 Emmet County Budget Amendment #1. All ayes, motion carried.

The Board discussed changes to the Emmet County Code of Ordinances. Sathoff will check with NW IA Planning on a question on page 49. The Board will place this review of the ordinances on the agenda each week until it is complete.

Board reviewed Joint Drainage Claim: ECD #61 Branch 61 Lat 119, \$560 to Rosacker Excavating. Motion by Quastad, second by Schumacher. All ayes, claim approved.
