Emmet County Attorney, Melanie Summers Bauler joined the meeting.

Chairman Glasnapp, called the meeting to order. All in attendance recited the Pledge of Allegiance. Motion by Quastad, second by Hansen to approve the minutes from the last meeting also approving them for publication. All Ayes, motion carried.

During Public Forum, Auditor Sathoff reported that Rob Patterson from the DNR had called the Auditor's Office with an update on the meeting with the geologist regarding the siltation issue in drainage district 44. He is hoping to get a meeting scheduled this week.

Auditor Sathoff shared with the Board a LOSST funds utilization report.

Sathoff also shared that early voting for the upcoming November 7, 2023 Combined City/School Election will start Wednesday, October 18<sup>th</sup>, 2023. Early Voting can be done Monday through Friday from 8:00 a.m. to 4:30 p.m. thru November 6, 2023. The last day to request a ballot to be mailed is October 23, 2023.

Quastad and Glasnapp met with the electrical inspector regarding utilizing the existing electric infrastructure for the proposed courthouse addition and the inspector said yes, it could be used. Quastad will share this information with CMBA and report back to the Board.

Quastad shared a drainage issue in DD56 Lat 3-2.

Schumacher attended a Conservation meeting and reported that hydrant installation is happening at Wolden and Tuttle Lake Parks. The Conservation Board also discussed the pending June 2024 retirement of Conservation Director, Eric Anderson.

Glasnapp reported on the courthouse fire drill held yesterday and the safety meeting he attended. November 20, 2023 will be defensive driving training for County Employees.

Bud Schnell joined the meeting, and the Board updated him on the progress of the drainage district 44 erosion report.

At 9:30 a.m. Chairman Glasnapp opened the public hearing regarding Chapter 36-Ordinance 2023-3-An ordinance regulating excavations and other soil disturbing activities in Emmet County, Iowa, for the purpose of preventing or minimizing the disturbance and transport of sediment into drainage districts and drainage district infrastructure. No public comments were received by the Auditor's office and no public comments were made at the meeting. Motion by Quastad, second by Schumacher to close the public hearing. The Second Reading will be held on October 17, 2023 and the Third Reading on October 24, 2023.

The Board continued discussion with Schnell regarding the siltation issue in drainage district 44. This will be put on next week's agenda for continued discussion.

Estherville Police Chief Brent Shatto, Emmet County IT Director, Trevor Duckett along with Estherville City Administrator, Penny Clayton joined the meeting to discuss the potential of sharing IT and Internet Services. Duckett mentioned that sharing services would increase security for both Emmet County and City of Estherville Police Department.

The Estherville Police Department currently share a phone system with the County and they receive an itemized statement each month for those services. An option could be a monthly fee, which the Police Department already is paying a vendor for.

The Board discussed potentially sharing IT services with the City of Estherville with Administrator Clayton, IT Director, Trevor Duckett and Chief Shatto.

Auditor Sathoff shared that currently the City of Estherville pays 28% of all Law Center expenses and is billed yearly for it.

A committee will be formed to discuss how the sharing could work. The Committee will include Schumacher, Bauler, Glasnapp, Clayton, Shatto and Duckett.

The Board reviewed the Emmet County Recorders first quarter FY2024 report.

The Board received citizen Brent Nelson's letter.
