Iowa Communities Assurance Pool (ICAP) annual visit report. Auditor Goebel shared the results from Cruise Davis, Risk Control Specialist. Davis suggested the county gets hold harmless agreements from drainage contractors. Board would like Goebel to move forward getting these out to the county drainage contractors. Attorney Summers Bauler will review the final form content prior to mailing them out to contractors. Davis also addressed some minor electrical outlet replacements. An electrician has been contacted to fix these outlets.

John Torbert from the Iowa Drainage District Association presented the annual report for the association. Drainage administrator training will be July 18, 2024 at 9:30 and the annual IDDA meeting will be December 6, 2024. The location of both meetings will be Best Western in Ft. Dodge. Torbert gave updates on legislation that pertains to the IDDA. There is a drainage improvement grant to incorporate conservation techniques in the drainage improvement. Water quality improvements would need to be paid from other sources, water quality is not assessed back to landowners only drainage repairs and improvements to land.
